I will make application to the **BonDeCroft Utility District** to be supplied with service at my property which is located:

1. I will cause the property described above which is owned or occupied by me to be connected with the water works system.
2. I agree to begin using water immediately after being notified by the District that water service is available.
3. I agree to use the water in accordance with the rules and regulations established by the District's commissioners (and subject to change from time to time) to promptly pay for the water at the applicable schedule of rates, and to pay all other applicable charges required by such rules.
4. I understand and agree to a tapping fee, if not previously paid, and to a connection fee as shown below to be charged. Applicants subscribing for water and the District will install free of other charges service lines from the main to the water meter.
5. It is understood that the tap and meter is to service only one residence, and shall not be diverted for any other purpose.
6. The water meter, cut-off valve, and line connecting them to the main, remains property of the District and may be removed by the District if service is discontinued.
7. My water bill is due on the date mailed to me by the District. A 10% penalty will be added if not paid before the discount date shown on the bill, and service will be discontinued if the bill is not paid within five days of the discount date. If service is discontinued for nonpayment of bill, no further service will be available until the bill, penalty and \$100.00 reconnect charges are paid.
8. In accordance with BonDeCroft Utility District's cross connection control program, a private well or auxiliary water source may not be connected in any manner to the public water supply unless proper protection against cross connection is provided.

It is further understood that if for any reason the District shall be unable to commence providing any water service as anticipated by this application, the full amount of the fees prepaid, as shown below, shall be refunded to me. I further understand that any bonds issued or any loans obtained to finance the District's water works system will not be a lien against my property and no taxes can be levied to pay the bond. I further understand that under the District's Rules and Regulations, I shall be liable for any costs that may be owing to the District under its Rules and Regulations after termination of my water service, including invoices, costs of repair of the District's meter or other facilities, invoices for statement and late penalties, unpaid fees, interest on all such obligations at the maximum legal rate, and court costs and reasonable attorney fees in the event the District shall employ the services of an attorney to collect such an amount.
